WHAT IS THE WHITE COUNTY EMPLOYEE POLL WORKER PROGRAM?

The White County Employee Poll Worker Program is a Board of Elections and Registration approved and White County sanctioned program that encourages employees to serve as poll workers, as needed, on Election Day and make a difference in their community. Employees must have the approval of their supervisor in order to participate.

WHAT WILL I DO?

As a White County Employee Poll Worker, you will:

- Be participate in a four hour training to qualify to work as a Poll Worker.
- Be on standby to work as a Poll Worker if the department has last minute cancellations.

WHAT ARE THE BENEFITS?

The program is open to any outgoing, friendly, customer oriented employee. It is intended to provide the flexibility of having trained force of workers willing to step in if called to assist the county to conduct elections; enabling citizens to have smooth and efficient experience at the polls.

Benefits include:

- The reward of contributing to your community in a meaningful way.
- Employees are given a day of Administrative Leave and are not charged a day of vacation.
- Employees will receive a stipend from the Board of Elections for their service.
 - \$25 for attending training
 - > \$160 for serving on Election Day.

WHAT SHOULD I EXPECT?

If you are called upon to serve, (normally between one to two days ahead of the Elections):

- Poll Workers arrive at the polling location at 6:00 AM to begin the day.
- © Close the polls and pack up the election equipment, normally, until 8:00 PM

- (a) 16 Years of age or older.

- © Cannot be an immediate relative of a candidate appearing on ballot where you are assigned to work.
